Kinds of Special Educational Needs that are provided for at St Vincent's Catholic Primary School and admission arrangements for children with Special Educational Needs</p>	<p>We provide support for pupils across the 4 areas of need as laid out in the SEN Code of Practice 2014:</p> <ul style="list-style-type: none"> <li>• Communication and interaction</li> <li>• Cognition and learning</li> <li>• Social, emotional and mental health difficulties</li> <li>• Sensory and/or physical needs</li> </ul> <p>Children with an Education Health Care Plan that names the school will be offered place without using the admission criteria and will count as part of the school's published admission number. Transition arrangements will be adapted to meet individual needs.</p>

Information about the school's Policies for identification and assessment of pupils with SEN</p>	<p>Pupils are identified as having SEN, and their needs assessed, through:</p> <ul style="list-style-type: none"> <li>• Information passed on from Nursery / previous schools;</li> <li>• Baseline assessments, progress and attainment tracking, KS1 and KS2 NC assessments;</li> <li>• Feedback from teaching staff and observations;</li> <li>• Pupil Premium interventions not showing impact;</li> <li>• Referrals from parents or pupils themselves</li> </ul>

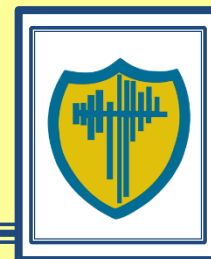

How the governing body involves other bodies, including health and social services bodies, local authority support services and voluntary organisations, in meeting the needs of pupils with special educational needs and in supporting the families of such pupils.</p>	<ul style="list-style-type: none"> <li>• The Governing Body are responsible for reviewing and approving policies relating to inclusion, SEN and disability, child protection and safeguarding. These policies outline how school will meet the needs of pupils with SEN and their families</li> <li>• The Governing Body receive regular updates from the Head Teacher and SENCo in order that they can ensure that children's needs are being met, and challenge as necessary and appropriate</li> <li>• Multi-agency meetings are held to ensure that all necessary agencies are involved in supporting the needs of any children with SEN</li> </ul>
<p>11. Arrangements for supporting pupil with special educational needs who are looked after by the LA</p>	<ul style="list-style-type: none"> <li>• The Designated Safeguarding Lead (also the appointed teacher for Looked after Children) will work closely with the SENCo to ensure that all needs are being met and that any targets to address concerns about learning and progress are also met within a child's PEP</li> </ul>

We will make sure that all records about your child are passed on as soon as possible.</p> <p><u>When moving classes in school:</u>          Information will be passed on to the new class teacher in advance and a planning meeting will take place with the new teacher. Individual targets will be shared with the new teacher. Your child will take part in transition visits to their new class in order to familiarise themselves with their new environment and get to know their new class teacher and teaching assistants with whom they will be working.</p>

The school's arrangements for supporting pupils with special educational needs in a transfer between phases of education or in preparation for adulthood and independent living (<i>continued</i>)</p>	<p><u>When leaving in Year 6:</u> The SENCo and Y6 teacher will discuss the specific needs of your child with the SENCo and head of year 5 of their secondary school.</p> <p>Where possible your child will visit their new school on several occasions and in some cases staff from the new school will visit your child in this school.</p>
